

**TERMS AND CONDITIONS**  
**FOR ADMISSION IN**  
**THE INTERVIEW PREPARATORY SESSION**  
**AT**  
**WORLD TIMES INSTITUTE**

You have reached this page through the website address provided at the base of the Admission Form (the **“Form”**) for joining the Interview Preparatory Session (the **“Session”**) at World Times Institute (**“WTI”**). Please read the below Terms and Conditions carefully as these constitute conditions precedent to the Admission at WTI and are non-negotiable.

That the Candidate/Aspirant undertakes and declares as to the correctness of the information required (and as provided) by him/her/them in the Form and warrants that he/she is authorized to provide/share such information/data. The Candidate/Aspirant further declares and agrees to bear full responsibility in case of any false, incorrect or misleading information/declaration and shall be solely liable for repercussions arising therefrom. The Candidate/Aspirant further undertakes to hold WTI, its employees and/or affiliates indemnified for all times, in case of any such repercussion, whether legal or otherwise.

That the Candidate/Aspirant agrees to provide any additional information, as may be required due to any subsequent change in the Form, if applicable.

That the Candidate/Aspirant hereby declares that he understands the Session at WTI is purely for educational purposes, whereby skills of a Candidate/Aspirant are honed so as to enable him to reach his/her/their full potential. The Candidate/Aspirant further understands and agrees that the Session at WTI does not guarantee any result and any Interview so taken by the Candidate/Aspirant depends solely on his/her/their individual performance and other ancillary factors.

That the Candidate/Aspirant shall deposit the Fee for the Session in advance and same shall be non-refundable at all times, without any exception.

That the Candidate/Aspirant shall attend the entire duration of the Session and perform the assigned tasks within the deadlines, where applicable. This shall enable the Candidate/Aspirant to gain maximum out of his/her/their stay at WTI.

That the Candidate/Aspirant shall adhere to disciplinary rules of WTI, affixed at the Notice Board at its entrance, which Rules may be construed as forming a part of these Terms and Conditions.

That without prejudice to the generality of Terms and Conditions as contained herein, the Candidate/Aspirant shall, at all times, conduct himself/herself/themselves in a manner that is compliant to our social, cultural and moral norms and/or legal requirements. While WTI reserves itself the right to expel any Candidate/Aspirant engaged in behavior that is or may be unbecoming and/or injurious to rights/sentiments/reputations of others, any such incident shall be solely between the candidates/aspirants with no liability of WTI at any time.

That WTI shall not be responsible for transportation, lodging and other ancillary matters of Candidate/Aspirant. Further, safety of Candidate/Aspirant especially outside the premises of WTI shall be their own responsibility and WTI and/or its employees shall be protected against such a liability at all times.

That only the Candidate/Aspirant shall communicate with WTI at all times, and no matter shall be discussed/entertained by WTI with the family/friends or other

acquaintances of the Candidate/Aspirant, unless expressly authorized through an affidavit, duly acknowledged by WTI.

That the Candidate/Aspirant understands that during the Session, WTI disseminates information (both written and verbal – in the form of lectures) which information (unless specifically provided) may not be construed as that of the Institute and responsibility whereof remains solely with the lecturer and/or the author of the book/article/resource material at all times. As such, the Candidate/Aspirant hereby unequivocally declares to hold WTI harmless due to any such information, its effect and correctness thereof.

That WTI engages the services of various subject specialists, public speakers, technical experts and other resource persons during the Session. The Candidate/Aspirant understands that their views do not represent those of WTI – as such, WTI cannot be held responsible for any such information. The Candidate/Aspirant further undertakes that he/she/they shall not approach any of the subject specialists, public speakers, technical experts and other resource persons in his/her/their individual capacity during the tenure of Session at WTI nor shall solicit individual/private coaching.

That the Candidate/Aspirant hereby undertakes not to further disseminate the information/material received at WTI during the Session.

That WTI believes in Intellectual Property Rights of others, and wherever, a book, article or resource material is relied upon, due credit is given to its author and publisher. The Candidate/Aspirant undertakes not to disseminate any such information/material without prior written approval and also as to responsibility arising therefrom.

That during the Session, various mini-mock interviews, mock interviews and full dress rehearsal interviews are held for the training (of the Candidate/Aspirant) and evaluation purposes. The questions asked therein do not constitute and/or represent the opinion/views of WTI and as such, responsibility remains with the Interviewer at all times. Also, it is hereby clarified that the score and/or remarks given at the end of such mini-mock interviews, mock interviews and full dress rehearsal interviews are tentative in nature and only represent the observation of the interviewer – as such, same are not conclusive and the ultimate score of the Candidate/Aspirant depends solely and wholly dependent on his/her/their performance in the final interview.

That the Candidate/Aspirant hereby expressly authorizes and consents to the use of information as provided by him/her/them in the Form, including but not limited to image as affixed therein (provided by the Candidate/Aspirant) and/or those obtained/captured during the Session (including but not limited to those from, classes, library, discussion room, mini-mock interviews, mock interviews, full dress rehearsal interviews etc) for dissemination on various social media pages/platforms/applications run/operated by WTI and/or print/electronic media purely for educational and motivational purposes and in recognition of work of the World Times Institute. Without prejudice to the generality of other provisions as contained herein, this provision shall survive the tenure of the Session.

That while WTI encourages sharing of information and healthy debate for educational purposes, the Candidate/Aspirant are advised not to engage in any discussion that may involve religious/sectarian underpinnings and as such, may outrage the religious/sectarian beliefs of fellow Candidates/Aspirants.

That the Candidate/Aspirant are hereby advised not to resort to debates/discussions that may constitute violation of any express provision of law – in which event, it shall be the sole liability of the Candidate/Aspirant and WTI shall be held harmless and indemnified at all times.

That the Candidate/Aspirant shall not cause any damage/degradation of the books, IT and other electronic equipment, furniture and other paraphernalia at WTI. Any loss shall be recoverable from the Candidate/Aspirant.

That the Candidate/Aspirant shall bear any arms/ammunition/weapon of any kind, whether licensed or otherwise, within the premises of WTI at any time. If a Candidate/Aspirant has any special security concerns, same shall be brought in the knowledge of WTI at the time of submission of the Form and WTI shall have exclusive discretion to entertain any such request for Admission in the Session.

That WTI reserves the right to refuse admission to any individual without assigning any reason and the applicant so refused hereby acknowledges to hold WTI, its employees and officials harmless and indemnified at all times.

That the Candidate/Aspirant shall not distribute, provide, use or be in possession of any narcotics substance, illegal drugs, psychotropic substances etc (including but not limited to cannabis, alcohol, heroin, amphetamine type stimulants - ATS, cocaine, opiates and poly drugs etc). Further, the premises of WTI are a Smoke Free Zone without an exception as per the extant laws.

That the video/audio recording and/or live/on call/radio dissemination of lectures and/or activities during the Session is strictly prohibited. In case of violation of this provision, in addition to any corrective measures that may be required under the law, the Candidate/Aspirant shall be liable to indemnify WTI and/or its resource persons in monetary terms as well.

That WTI reserves the right (without notice) to alter/amend/repeal/substitute any/all Terms and Conditions as contained herein and the Candidate/Aspirant shall be bound by any/all such provisions without any exception. As such, please visit this page every week to stay updated about any such changes.

That in case of breach of any of the Terms and Conditions as contained herein, without prejudice to other remedies that may be available under extant law(s), WTI reserves the right to expel the Candidate/Aspirant immediately, without notice and without any compensation whatsoever. Especially in case of any incident that brings disrepute to the organization and/or tarnish the image of WTI, its employees and affiliates, WTI reserves the right to have recourse to appropriate legal remedies.

That, it must be noted (as is provided in the Form as well) that admission in the Interview Preparatory Session at World Times Institute is subject to and shall be



governed by the Terms and Conditions as mentioned hereinabove and shall operate the during the entire session and in certain cases, shall survive the term of the Session at WTI and the Candidate/Aspirant understands, agrees and accepts all such stipulations without any exceptions. If a candidate does not agree to above stipulated Terms and Conditions, he/she/they shall not seek admission at WTI. As such, by joining the Session, a Candidate/Aspirant shall deemed to have read/understood/agreed and accepted the Terms and Conditions contained hereinbefore.
